UTILITY COST REDUCTION AGREEMENT

We, the undersigned, hereby retain PUBLIC UTILITY REFUNDING, INC., to assist us in lowering and managing our utility costs.

I. PURPOSE AND DURATION OF AGREEMENT

The purpose of Agreement is to state the terms and conditions under which PUBLIC UTILITY REFUNDING, INC., is to provide CLIENT with Consulting Services designed to reduce Utility Costs.

In Consideration of the mutual promises contained with this Agreement, the parties agree to the following:

II. SERVICE TO BE PERFORMED

PUBLIC UTILITY REFUNDING, INC. will analyze previous 6 years of utility bills for billing discrepancies and forward 2 years.

III. COMPENSATION TO PUBLIC UTILITY REFUNDING, INC.

- A. No fee will be due PUBLIC UTILITY REFUNDING, INC., unless and until actual refunds/credits or reductions in transmission and delivery charges are received from our utility suppliers.
- B. Client agrees to pay an amount equal to 50% of each collected and/or realized refund/credit and reductions in transmission and delivery charges as a result of a tariff conversion to PUBLIC UTILITY REFUNDING, INC., within 30 days of invoice.

IV. MISCELLANEOUS

- A. CLIENT agrees as follows: (A) to execute a Letter of Authorization to permit PUBLIC UTILITY REFUNDING, INC., to deal with utility companies on behalf of CLIENT in all respects to apply for any refunds and savings due CLIENT; (B) to permit employees of PUBLIC UTILITY REFUNDING., INC. access to premises of CLIENT during normal business hours for the purpose of inspecting meters and to cooperate with PUBLIC UTILITY REFUNDING, INC., in all matters pertaining to obtaining refunds and savings; (C) to hold PUBLIC UTILITY REFUNDING, INC., harmless in the event CLIENT'S pattern of usages changes.
- B. Parties to Be Bound: This Agreement shall be binding upon the parties hereto and their receptive heirs, successors and/or assigns.
- C. PUBLIC UTILITY REFUNDING, INC., is hereby authorized to act as CLIENT'S agent in obtaining billing information from Utility Companies.
